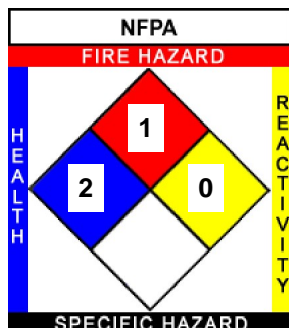

## 4 FIRST AID MEASURES
