**SECTION 4. FIRST AID MEASURES (CONTINUED)**

**SKIN CONTACT:**

If the product contaminates the skin, immediately begin decontamination with running water. Minimum flushing is for 15 minutes. Remove contaminated clothing, taking care not to contaminate eyes. ### **ENVIRONMENTAL PRECAUTIONS:**

### **HANDLING**
